More than 35 years ago the American Nursing Association identified nursing peer review as a necessary part of the professional nursing practice.

West Kendall Baptist Hospital (WKBH) opened its doors April 27, 2011. Nursing Peer Review (NPR) comprised mostly of bedside nurses is part of WKBH's Shared Governance Model and reports monthly to the Cultural Competence Council.
